Guidelines for condemnation of University vehicle. A vehicle may be declared condemned after observing the following guidelines:

Life of a Vehicle

The provisions of Financial Code, Schedule 6, item 4 of appendix, page 303, rules, a vehicle can be provides as per declared condemned after completion of 8 years or run of 1.50,000 kms, whichever is later. Howe er, prior sanction of the competent authority shall be obtained to the writing off all the delegation of powers. VC is the competent authority.

2. <u>Vehicle Condemnation Certificate</u>

It can be obtained from Mechanical Workshop of the Airport Authority/Workshop of a state Certificate Road Transportation Corporation by sending a request letter for inspection of the Vehicle. If the above workshops are not available, transport Workshops under the Central or State Govt, Dept.

3. Reserve Price

Reserve Price for the articles shall be got fixed, before—the auction,—with the approval of the competent authority,—taking open market

The Reserve Price may be obtained in a scaled cover—from Airport—Authority—Workshop (i.e. the inspecting Authority) which will be opened in the presence of a committee constituted for this purpose by the Vice-Chancellor.

. Advertisement

Advertisement will be issued incurring minimum expenditure regarding public auction of the vehicle as is where is basis". For the auction, an officer not below in the rank of Lecturer/Head of the Unit should be nominated.

5. Auction Process

The quotations received in response to the advertisement will be opened by the committee constituted for this purpose. If the offer of highest bidder is more than reserve price, offer of highest bidder will be accepted. If the Offer of highest bidder is less than the reserve price then approval from the Vice Chancellor has to be obtained to offer the vehicle to the highest bidder.

6. Delivery of the Vehicle

At least 25% of the accepted bid shall be recovered from the successful bidder on the spot. Vehicle can be handed over to maximum Price quoted bidder after collecting the full bid value of the vehicle in the presence of Head of Unit or his nominee...
