**Sub: Action Taken Report with respect to Shifting of students from Special Study Centre to Regular Study centre – reg.**

Sir,

**1. Reason for Shifting:** Due to the Policy directive of the University to convert Special Study centre to Regular Study Centre, the process for the same is pending at the Host Institution end. Ideal Training College SSC14134D) has specified sister concern Institution to shift the special LSC/Establish new LSC. Certain discrepancies were notified verbally to the Management of the Institution.

The proposal from Ansar Women's College (SC14182D) was received on 14<sup>th</sup> February, 2022, Ideal Training College (SC14134D) was received on 13<sup>th</sup> December, 2021 and Bharatmata College (SC14165D) was received on 13<sup>th</sup> May, 2022.

It is submitted that since provision was given to Special LSC to submit the Regular LSC format, the LSC code was listed for admission. Certain LSC like Jail and Union Territory of Lakshwadeep which do not claim any share money has been retained. Verbal discussion with other Special Study Centres did not arrive at any fruitful result for their functioning without claiming share money during the lag period of being converted into Regular LSC. Hence, the need for shifting of Learners from Special LSC to Regular LSC. Since the Coordinator of the Regular LSC in the same District has expressed inability to accommodate more Learners, the RC has shifted the Learners to nearby LSC around the District.

In the case of below 150 enrolment, consequently for 5 admission cycle sessions, the learners has been shifted from Low enrolment LSC (after verbal discussion failed to accommodate Learners without remuneration) to nearest LSC which has fulfilled the minimum enrolment number.

**2. Letters sent to the Learners:** The first email dated 25<sup>th</sup> April, 2022 has been sent to Learners regarding shifting (enclosed as Enclosure 1) of LSC from Special Study Centre to Regular Study Centre. The Second Email (Enclosure 2) was also sent on 14<sup>th</sup> February, 2022. In addition, the letter sent to the student has been uploaded in the RC Cochin website and can be accessed at the link <http://rccochin.ignou.ac.in/Ignou-RC-Cochin/userfiles/file/ab-1.pdf>. Hence, the students are not put into inconvenience.

**3. Prevalence of new normal situation which will not hamper the Student convenience:** For all Student Supporting Services, Study Centre would be contacting the student by Email/Whatspp/SMS. The Counselling classes are being scheduled online (Virtual mode). Hence, mobility to Learner Support Centre (LSC) is not mandatory.


